Please explain how the LEA will determine its most important educational needs as a result of COVID-19. (3000 characters max)

The Bristol Borough School District is using several methodologies to determined its most important educational needs as a result of COVID-19. First, the district is using summative assessment data, such as the PSSA and Keystone assessments. The district also has several benchmark assessment programs that are used school wide to determine progress and learning loss in specific content areas. Students with special needs are being progress monitored by their teachers to determine learning loss. The district also has quarterly report card grades, which can be used to determine learning loss and need based on progress through the curriculum. The district is also using information collected from our guidance department and MTSS records to assess the need for increased mental health services for our students. Parent input is also being sought to determine the educational needs of our students. The district has asked for feedback from parents via a survey to determine the need to continue with some form of virtual instruction in the 2021-2022 school year. The Principal from the St, Mark School, our nonpublic school, was consulted by phone and email to determine the needs of her students and teachers.

Please explain the LEA(s) proposed timeline for providing services and assistance to students and staff. (3000 characters max)

The BBSD's timeline:2020-2021 School year: Students in the district were provided with fully virtual synchronous instruction. In October, parents who wanted their students to come back to the buildings were given a hybrid instructional model. From mid-November through the beginning of January, students were once again educated using a fully virtual option due to the high COVID numbers in the county and the chance of disease spread during the holidays. In January, students were once again given a hybrid instructional model for live instruction. In April, students were given the option for fully live instruction 5 days a week in addition to the virtual option. Regardless of the mode of instruction, all students received the opportunity to receive any and all services needed for their continued success. For students who were not

physically present in the buildings, all additional services such as speech, OT, PT and counseling were provided through virtual options. All students were eligible for free breakfast and lunch. Those who were virtual had the option of picking food up at the school buildings. In order to facilitate the online learning platform as well as serve the needs of those students who were physically present in the building, all students were given a Chromebook. Students who did not have access to the internet were issued a district hotspot. Teachers were also given Chromebooks, as well as other technology to teach students who are both live and virtually synchronously. As we move into the summer, we have moved into planning for our extended school year services for our students with disabilities. They year, ESY will be open to all students with special needs. We also are providing credit recovery options and small group instruction to address learning loss for our students. In addition, we have surveyed our families to determine instructional mode options for the 2021-2022 school year. Our intention is to provide a district run virtual option as well as full live instructional option for our students in 2021-2022. We will continue to use Google classroom as our platform for all classes so students can stay connected with their teachers if there is a need to go virtual again due to increased COVID numbers. To address the increased mental health needs of our students we plan to offer school based social work and family counseling services. We also plan to address the increased truancy rates as a result of COVID through these means. The district will address the changing guidance for schools via our Health and Safety Plan as new information becomes available.

Please explain the extent to which the LEA intends to use ESSER II funds to promote remote learning. (3000 characters max)

The Bristol Borough School District intends to use ESSER II funds to promote remote learning and to support a safe environment in which to learn. The educational technology proposed for purchase (including hardware, software and connectivity) will support the distance learning structure. The academic needs of all students are supported through the use of this technology, whether in a remote setting and/or classroom setting, in the hands of every Bristol Borough student: differentiation for all levels of student needs can be achieved through the use of standards-based, educational online programs. The Health and Safety Plan was approved by the School Board on August 6. The plan includes information on the following topics: cleaning, sanitizing, disinfecting and ventilation, social distancing, monitoring student and staff health, communications plans, material and resource acquisition and contact tracing protocols.

Please describe how the LEA intends to assess and address student learning gaps resulting from the disruption in educational services. (3000 characters max)

The Bristol Borough School District intends to assess and address student learning gaps resulting from the disruption in educational services by purchasing software that can identify, design, and facilitate the targeted needs of our students' academic growth. The academic programs purchased will prepare students for the upcoming school year. The programs will deliver real-time performance data, provide teachers data-driven action plans to help differentiate instruction for each student. The previous grade level materials, which were modified due to COVID-19, will continue in focus and depth until skill base is assessed.

Learning objectives will solidify the skills needed for academic success, thus promoting a comfortable learning environment for the Fall of 2021. The district also plans to use summative data from assessment programs what are already in place that have been used to collect data and assess progress throughout the year. In addition, we plan to use standardized test data from the PSSA and the Keystone exams to assess student progress. Learning gaps will be addressed through summer offerings such as ESY, credit recovers, and targeted small group instruction. Gap in the 2021-2022 school year will be addressed through increase remedial opportunities for students using teaching and support staff as well as computer bases learning opportunities. In addition, small group and individualized tutoring options are available for students who need additional support. Credit recovery options are also available to all middles and high school students who need additional support to address their learning needs due to COVID.

Students will be able to communicate with teachers and access classroom activities. Teachers can evaluate each students' work and specifically address individual strengths and needs.
